## NEW HAVEN ROWING CLUB

Acknowledgement of Risks, Release of Liability, and Indemnification Agreement for Rowing

It is mandatory that each Club Member, Visitor, or Guest read and sign this Acknowledgement of Risks, Release of Liability, and Indemnification Agreement for Rowing ("Release") before participating in any New Haven Rowing Club rowing programs.

IN CONSIDERATION of being given the opportunity to participate in any NEW HAVEN ROWING CLUB ("Club") activities ("Rowing Activities"), now and until the end of my association with the Club, I, for myself, my personal representatives, agents, assigns, heirs and next of kin:

- 1. ACKNOWLEDGE, AGREE, AND REPRESENT that I understand the nature of Rowing Activities, both on water and land based; and that I am qualified, in good health, and in proper physical condition to participate in such Activities.
- 2. ACKNOWLEDGE, AGREE, AND REPRESENT that I understand that: (a) ROWING ACTIVITIES INVOLVE RISKS AND DANGERS of serious bodily injury, permanent disability, paralysis, and death, as well as risks to property ("Risks"); (b) these Risks may be caused by the conditions in which the Rowing Activities takes place, by my own actions or inactions, the actions or inactions of others participating in the Activities of others in the vicinity, or by the actions or inactions or NEGLIGENCE OF THE RELEASEES named below; (c) the Risks, as well as other risks and economic losses that may result from my participation in the Rowing Activities, may not be known to me or readily foreseeable; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USRowing; the Club; for both USRowing and the Club their administrators, directors, agents, officers, volunteers and employees; other participating Regatta organizers, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Rowing Activities take place (the "Releasees") from all liability, claims, demands, causes of action, losses or damages related to my participation in the Rowing Activities, including those caused or alleged to be caused in whole or in part by the NEGLIGENCE OF ANY OF THE RELEASEES in evaluating rowing conditions, in setting safety limits on Rowing Activities in specific conditions, in permitting me to engage in any Rowing Activities, in engaging in negligent rescue operations, or in taking or failing to take any other actions in connection with my participation in any Rowing Activities; and I further agree that if, despite this acknowledgement of risks and release of liability, I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD
